Eligible States/ Territories/ Countries	Queensland, Australia
Promotion Period	Monday to Thursday 4pm to 6pm each week ongoing until the venue determines otherwise.
Eligible entrants	Patrons who have made any food or beverage purchase in the Public Bar within the hour before a draw. Australian residents who are aged 18 years or older. Directors, management and employees of the Promoter are not permitted to enter. Excluded or Banned patrons are not permitted to enter the gaming area of any venue or participate in any promotion. Entries from banned or excluded persons will be disqualified and forfeited.
Purchase of Product	The entrant is required to purchase any food or beverage item one hour before the draw, to a total spend of no less than \$5.
The Prize	The Prize Wheel consists of 20 prize slots; this is broken down into the following prize offers and quantities. 1x Jackpot (or \$50 Pass voucher if the jackpot has been claimed that week) 3x \$20 Pass vouchers 4x \$10 Pass vouchers 4x Booby Prizes 4x Spin Again's 4x Complementary Drink's Prize details: Jackpot: The jackpot starts at \$100. This will jackpot weekly by \$100 until won. When the jackpot is won, the jackpot slot is removed and replaced with a \$50 Pass voucher prize until the following Monday when the new jackpot value restarts at \$100. \$50 Pass Voucher: The manager will email or print a \$50 Pass voucher at the time for the winner. The voucher is valid for 3 years and can be redeemed at any AVC venue in line with AVCs voucher Terms and Conditions. \$20 Pass Voucher: The manager will email or print a \$20 Pass voucher at the time for the winner. The voucher is valid for 3 years and can be redeemed at any AVC venue in line with AVCs voucher Terms and Conditions. \$10 Pass Voucher: The manager will email or print a \$10 Pass voucher at the time for the winner. The voucher is valid for 3 years and can be redeemed at any AVC venue in line with AVCs voucher Terms and Conditions. Booby Prizes: No set prizes outlined. This is a prize at random and will be determined by the team member running the promotion at the time. Examples what the patron may win include, a free meal, chocolate bar, packet of chips, cooler, toasted sandwich etc. Spin Again: The patron may spin again until the wheel lands on a redeemable prize. Complementary Drink: Options limited to either a schooner of local beer, house spirit, small house wine, schooner of a non-alcoholic product or a prepacked non-alcoholic drink.
Total prize value	Dependant on corresponding prize won.

Total number of prizes	3 prizes per promotional day totalling 12 prizes weekly.
Method of entry	1) To enter the promotion, patrons must be seated on a bar stool in the Public Bar during the days and hours of the promotional period. 2) All bar stools in the public bar are numbered with their own unique number located under the base of the bar stool. This will be how the customer determines the numbered stool they are sitting on. 3) The team member will use a random number generator to generate a number no greater than the number of stools available in the Public Bar. 4) The customer sitting on the corresponding bar stool is to advise the team member, they have that number stool. 5) The team member is required to verify the number on the bar stool matches the number generated before the customer has a chance to spin the wheel.

Prize draw details	The draw will be held in the Public Bar on the following days and times: - Monday 4pm, 5pm, 6pm - Tuesday 4pm, 5pm, 6pm - Wednesday 4pm, 5pm, 6pm - Thursday 4pm, 5pm, 6pm The winning patron has a chance to spin the wheel to determine which prize they have won. The wheel when spun, must minimally complete a full spin of 360 degrees in order for the spin to be valid. When the wheel stops spinning, the toggle located at the top of the wheel will determine which prize the customer has won.
Notification of winners	The team member will announce they are about to commence the next draw 5 minutes before the draw. The team member will activate the number generator that will be displayed in prominent position for Public Bar patrons to see. In addition to this, the team member will also announce the number that has been generated within the Public Bar only. In the event no one is sitting on the corresponding stool, the number generator will be generated again to select another number. This process will continue until a numbered stool is claimed. There is a 30 second allowance for the customer to advise staff they have the corresponding stool before another number is generated. The Promoter has no liability to anybody who is hearing impaired or otherwise disabled, unless the Eligible Entrant has made the Promoter aware of such in writing.

Claiming the Prize	Prizes must be claimed on the day of the win. The team member running the promotion each day will record the day, date, time, winners' name and prize won on the prize register. The prize register will be required to be signed by the customer on receiving their prize.
